SUBJECT: Equal Employment Opportunity and Affirmative Action Policy Statement

APPLIES TO: All Employees and Applicants for Employment

Technology Integration Group (Corporate) is an equal opportunity employer and provides equal opportunity in employment for all qualified persons. Technology Integration Group (Corporate) makes employment decisions including, but not limited to, recruiting, hiring, promotion, demotion, training, compensation, benefits, disciplinary actions, and terminations on the basis of merit. Employment decisions are based on an individual's qualifications as they relate to the job under consideration. Employment decisions will be based on the principles of equal employment opportunity and with the intent to further Technology Integration Group (Corporate)'s commitment to affirmative action and equal employment.

Technology Integration Group (Corporate) will take affirmative action to ensure that qualified minority group individuals, females, individuals with disabilities, or protected veterans are introduced into the workforce, encouraged to apply for promotion, and considered as promotional opportunities arise.

Technology Integration Group (Corporate) also prohibits unlawful discrimination based on the perception that anyone has any of those characteristics. All such discrimination is unlawful.

Technology Integration Group (Corporate) is committed to compliance with all applicable laws providing equal employment opportunities. This commitment applies to all persons involved in Technology Integration Group (Corporate)'s operations and prohibits unlawful discrimination by any employee of Technology Integration Group (Corporate), including supervisors, coworkers, and subordinates. Your complaint should be specific and should include the names of the individuals and witnesses involved. We will promptly undertake an effective, thorough, and objective investigation and attempt to resolve the situation.

If we determine that unlawful discrimination or a violation of this policy has occurred, effective remedial action will be taken commensurate with the severity of the offense, up to and including termination. Appropriate action also will be taken to deter any future discrimination.

There will be no retaliation against any employee who brings a complaint under the equal employment opportunity policy or who assists in investigating such a complaint, even if the investigation produces insufficient evidence that there has been a violation, or if the charges cannot be proven.

Employees and applicants are encouraged to identify their race, gender, disability status, and their protected veteran status. This self-identification is strictly voluntary, confidential, and will not result in retaliation of any sort.
